This award will be presented to an Art Educator or a Collaborative Group who:

- demonstrates that their praxis is aligned with the mission of InSEA to entitle all learners (regardless of age, nationality, or background) to access visual art education that deeply connects them to their world and to their cultural history that inspires knowledge, appreciation, and creation of new horizons that develop new ways of seeing, thinking, doing, and being (see InSEA Manifesto, InSEA Website),
- has demonstrated a commitment to multicultural and cross-cultural educational curricula in their schools and communities,
- has demonstrated leadership,
- implements pedagogical approaches that build respect for human dignity and diversity through art, and
- fosters teamwork, collaboration, and communication among diverse constituencies in order to achieve greater understanding of the social and cultural aspects of art and visual culture in education.

Individuals and/or groups receiving this award must be members of InSEA at the time of receiving the award. Candidates meeting a minimum of two of the above criteria can self-nominate or be recommended by other art educators. Nominations should be emailed to the nominees' regional World Councilor.

The award decision will be announced at the Regional Congress or in the World Congresses.

The recipients will be announced in the InSEA News and on the InSEA website.
